4a (Code:) (Expenses \$ 130839. including grants of \$) (Revenue \$) Bible Distribution - Distribution of Bibles and religious literature to Prisons, Hospitals, Shelters, Soup Kitchens, and churches in 2014, Chicago Bible Society provided 9,045 bibles and other scripture resources to churches and institutions, including 1,964 bibles to prisoners, 2,360 bibles and scripture materials to courtside ministries, and 4,721 were provided to churches, shelters, hospitals, and other institutions.

4b (Code:) (Expenses \$ 87222. including grants of \$) (Revenue \$) Scripture Encouragement - Sponsoring bible study and education programs to encourage the reading and understanding of the Bible. In 2014, Chicago Bible Society sponsored Bible study small groups in churches, jails and other institutions. This year, 142 persons participated in the small groups, with 100 professions of faith. Programs are run in both English and Spanish languages. Cumulative totals for the eight years of the project 1,144 enrolled, 930 graduated and 614 have made a first time profession of faith. Childrens Urban Literacy-35 students completed the pilot project. The program teaches reading skills to 1-2 grade students using Bible-based reading materials.
